Medical Education – APHERMC – Fixation of Fee to the Post Graduate Medical and Post Graduate Dental courses in Private Un-Aided Professional Institutions (Non-Minority and Minority) in the State of Andhra Pradesh, for the block period 2017-2018 to 2019-2020 – Notification U/s 7 of Act No.5 of 1983 – Issued.

ORDER:

In the G.O.s 1st and 2nd read above, Government have issued orders fixing the fee for the academic year 2017-18 for the students admitted into Professional Post Graduate Medical and Dental Courses i.e.MD/MS/Diploma/MDS to the Private Un-aided Non-Minority and Minority Medical and Dental institutions entering a consensual arrangement with the AP Private Medical and Dental Colleges Managements Association and without recommendations of the AFRC. These orders have been challenged before the High Court by fling WP (PIL) and Writ petitions.

- 2. In the reference 3rd read above, the Hon'ble High Court in its Common Order dt.20.01.2021 in Writ Petition (PIL) No. 131 & 132 of 2017, W.P Nos.16990, 17102 & 17104 of 2017, W.P No.19755, 19764 & 19802 of 2019, W.P. Nos.1323, 1324, 1327 & 6893 of 2020 along with other matters, has set aside the orders issued in G.O.Ms.No.72, HM&FW (C1) Dept., Dt.3.5.2017 and G.O.Ms.No.77, HM&FW (C1) Dept., Dt.6.5.2017, on the ground that they fall foul of the directions of the Hon'ble Supreme Court in Islamic Academy and P.A Inamdar and are also not in accordance with G.O.Ms.No.6, Dt.8.1.2007 and directed the Government to notify the fee recommended by the Commission within one week of receiving the recommendations.
- In the Letter 4th read above, the Member Secretary and CEO, AP Higher Education Regulatory and Monitoring Commission (APHERMC) has informed that the Hon'ble High Court in WP (PIL) No. 131 & 132 of 2017 and batch dated. 20.01.2021, while upholding the orders of the Government in G.O.Ms.No.70, HM&FW (C1) Dept., Dt.3.5.2017 with regard to the seat sharing of PG Medical and PG Dental Courses, pursuant to the consensual agreement dated.02.05.2017, quashed the provisions of the Consensual agreement dt.2.5.2017 to the extent of fixation of Fee unilaterally and consequently the G.O.Ms.Nos.72 & 77, HM&FW (C1) Dept., Dt.03.05.2017 and 06.05.2017 respectively were set aside on the ground that they fall foul of the directions of the Hon'ble Supreme Court in the Islamic Academy and P.A. Inamdar cases and also on the ground that the process adopted for fee fixation was not in accordance with the drill stipulated under Rules issued in G.O.Ms.No.6, Dt.08.01.2007. Pursuant to the aforesaid directions of the Hon'ble High Court, the Commission issued notification to call upon the Private Un-Aided P.G. Medical and P.G Dental colleges to submit the Fee proposals for scrutiny and determination of the Fee structure as per the directions of the Hon'ble High Court for the block period of 2017-18 to 2019-20.

- 4. The Andhra Pradesh Higher Education Regulatory and Monitoring Commission (APHERMC) examined the Fee proposals submitted by the Medical and Dental Colleges pertaining to PG Medical and Dental courses, to review and determine the Fee Structure for the block period 2017-2018 to 2019 -20 and finally determined the Fee in its Meeting held on 06.04.2021. The Commission has requested the Government to consider and notify the Fee Structure U/s 7 of Andhra Pradesh Educational Institutions (Regulation of Admissions and Prohibition of Capitation Fee) Act, 1983 (Act No.5 of 1983), subject to the directions mentioned in the minutes of the meeting and the directions that may be mentioned by the Government in its orders.
- 5. Government after careful examination of the matter, hereby issue the following Notification which shall be published in the Andhra Pradesh Extraordinary Gazette:

NOTIFICATION

- 6. In exercise of the powers conferred under Section 7 of Andhra Pradesh Educational Institutions (Regulation of Admission and Prohibition of Capitation Fee) Act, 1983 (Act No.5 of 1983), the Government considered the fee structure recommended by the APHERMC, determining the fee structure to the Post Graduate Medical and Post Graduate Dental courses in Private Un-Aided Professional Institutions (Non-Minority and Minority) in the State of Andhra Pradesh, for the block period 2017-2018 to 2019-2020.
- 7. The Government, hereby notify the Fee Structure for to the Post Graduate Medical and Post Graduate Dental courses in Private Un-Aided Professional Institutions (Non-Minority and Minority) in the State of Andhra Pradesh, for the block period 2017-2018 to 2019-2020. The details of college-wise Fee structure for the PG Medical and PG Dental Courses are appended to this order as Annexure-I & Annexure-II respectively.
- 8. The above said fee structure notified by the Government under Section 7 of Act 5 of 1983 for the block period 2017-18 to 2019-20 is subject to the following conditions:
 - a. The Fees are all—inclusive annual fees including tuition fee, admission fee, special fee, computer/internet fee, maintenance and amenities fee, extracurricular activities fee, development fee and other recurring expenditures.
 - b. The aforesaid Fees determined for all the PG Medical Courses and PG Dental courses for the colleges mentioned in Annexures-I and II respectively do not include hostel, transport, mess charges, refundable deposits like laboratory/library fee, etc.
 - c. The Minimum of the Fee structures for all the PG Medical courses and PG Dental Courses, as Mentioned in Annexures I and II respectively, shall be applicable for the new Courses/Colleges sanctioned during the block period 2017-18 to 2019-20.
 - d. The Institution shall collect the annual Fees for every year in two half yearly instalments in advance.
 - e. The same Fees shall continue for the students admitted during the block period of 2017-18 to 2019-20 till they complete their course.
 - f. The institution shall not charge either directly or indirectly any other amount over and above the Fee fixed in the Annexures. If any other amount is charged under any other head or guise i.e., donations, the

- same would amount to charging of capitation fee and the concerned institution shall be liable to be prosecuted under Section 9 of Act 5 of 1983 apart from imposition of appropriate penalty under the APHERMC Rules, 2019.
- g. Stipend shall be paid to the PG students on par with the students in the Government PG Medical and Dental Colleges.
- h. In case of any deviation from these directions, the Commission will be at liberty to initiate serious penal action as per the provisions of APHERMC Act and Rules made thereunder.
- 9. The Registrar, Dr.NTR University of Health Sciences, Vijayawada / Director of Medical Education shall take further necessary action accordingly.
