NOTIFICATION

In exercise of powers conferred by sub-section (1) of section 22 of
The Andhra Pradesh Higher Education Regulatory and Monitoring
Commission Act, 2019 (Act.No.20 of 2019)and amended subsequently, the
Govt., hereby approve the following amendments to the Andhra Pradesh
Higher Education Regulatory and Monitoring Commission Regulations,2020.

AMENDMENTS

In the said regulations, in regulation 5,

(i) for sub-regulation (10), the following shall be substituted, namely;

“(10) In order to consider the expenditure on teaching and non-
teaching staff, the cadre strength fixed by the respective regulatory
authorities and accreditation bodies needs to be complied”.

(ii) for the sub-regulation (22), the following shall be substituted, namely;

"(22) All particulars should be uploaded online. The Institution shall provide a hard copy of the uploaded information duly signed by the auditor and the Head of the Institution /their authorized person, by remitting prescribed processing charges. The charges shall be credited to the Account of the Commission as notified on the website of the Commission."

(iii) for the sub-regulation (36) (b), the following shall be substituted, namely;

"(36) (b) The institution shall be at liberty to collect the fee for the Management quota seats upto the limit notified by the Government in order to maintain quality of education by providing proper infrastructural and instructional facilities and amenities;

3. The Secretary, the Andhra Pradesh Higher Education Regulatory and Monitoring Commission, shall take necessary action accordingly in the matter.
