**The Un-Aided Private Engineering Higher Educational Institutions in
the State of AP**

Hon'ble High Court in I.A.No.4 of 2022 in W.P.No.35109 of 2022 (Andhra Pradesh Private Engineering Colleges Managements Association and another Vs. State of Andhra Pradesh and another), the Private Engineering Higher Educational Institutions are permitted to upload data by paying processing fee without penalty till 05.01.2023. The operative portion of the orders dated 21.12.2022 is extracted hereunder:

“.....

In that view of the matter, respondent No. 2 is directed to open the website forthwith and the petitioners are permitted to upload the data on or before 05.01.2023 and also pay the processing fee without penalty by that date.


....”

The web-portal to upload data is open for the petitioners who have not uploaded the data as on 20.12.2022 and also for other colleges who have already uploaded the data and have frozen the portal.
