**ORDER:-**

The Member-Secretary, A.P. Higher Education Regulatory and Monitoring Commission in his letter 4<sup>th</sup>, 5<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup>, 8<sup>th</sup> & 9<sup>th</sup> read above has stated that the Commission has received representation from the colleges mentioned in the Annexure, stating that they have received AICTE approvals followed by the affiliation orders from the corresponding Universities for BBA & BCA programmes in their colleges from the academic year 2024-25 and requested the Commission to determine the fee for the said programmes and also stated that the AICTE approved the applications of the Institutions mentioned in the Annexure, to conduct the new Programmes mentioned in Annexure as per the orders noted to the tuition fee as fixed already to the UG Un-Aided degree colleges, may be adopted to UG programmes offered by Private Engineering, Standalone colleges and Degree colleges also. Thus, the Commission has examined all the data submitted by the said colleges and recommend the minimum fee to the said programme as mentioned in the Annexure, as notified in the G.O.Ms.No.22, Higher Education (R.M) Department dated:12.07.2023.

2. The Member-Secretary, A.P. Higher Education Regulatory and Monitoring Commission in his letter 4<sup>th</sup>, 5<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup>, 8<sup>th</sup> & 9<sup>th</sup> read above has furnished the proposals of the colleges as mentioned in Annexure along with the recommendations regarding the fee structure for new BBA & BCA programmes offered by Private Engineering, Standalone Higher Educational Institutions and Private Un-aided Higher Educational Degree Colleges in the state of Andhra Pradesh for the Academic Years 2024-25 and 2025-26 and requested to issue necessary Notification in the matter, under Section 7 of Andhra Pradesh Educational Institutions (Regulation of Admission and Prohibition of Capitation Fee) Act, 1983 (Act No.5 of 1983).

3. Government after careful examination of the matter, hereby issues the following Notification which shall be published in the Andhra Pradesh Extra-Ordinary Gazette:-

### **NOTIFICATION**

In exercise of the powers conferred under Rule 8 of the Andhra Pradesh Higher Education Regulatory and Monitoring Commission Rules, 2019 issued in G.O.Ms.No.49, Higher Education (UE) Department, dated: 11.10.2019 as amended subsequently from time to time, the A.P. Higher Education Regulatory and Monitoring Commission recommended the fee structure for new BBA & BCA programmes offered by Private Engineering and Standalone Higher Educational Institutions in the state of Andhra Pradesh for the Academic Years 2024-25 and 2025-26.

Further, in exercise of the powers conferred under Section 7 of Andhra Pradesh Educational Institutions (Regulation of Admissions and Prohibition of Capitation Fee) Act, 1983 (Act No.5 of 1983), Government hereby notify the Fee as mentioned in the Annexure appended to this Order for the academic years 2024-25 & 2025-26, subject to following directions:

- a. The fee is an all-inclusive annual fee, including like tuition fee, affiliation fee, cost of identity card, medical fee, inter college/inter university sports, games & cultural meet fee, computer/internet fee, College magazine and student activities, student health care scheme, student welfare fund, study tour, alumni fund, sports and games fee, examination fee including stationery, maintenance and amenities fee, extracurricular activities fee, development fee, Recognition fee, Common Services fee and other recurring expenditure;
- b. The same fee shall continue for the students admitted during the academic years 2024-25 & 2025-26 till they complete the programme.
- c. The institutions whose affiliations are not extended by the affiliating Universities for the academic year 2022-23 are not entitled to collect any fee;
- d. In case of a new college/course, the fee structure shall be the minimum of the fee regulated for the institutions in the same programme or course for the academic years 2024-25 & 2025-26.
- e. The institution shall not charge either directly or indirectly any other amount over and above the fee fixed in Annexure (Fee determination for new BBA & BCA programmes for the academic years 2024-25 to 2025-26). If any other amount is charged under any other

head or guise i.e., donations, etc. the same would amount to charging of capitation fee and in that case the institution shall be liable to be prosecuted under Section 9 of Andhra Pradesh Educational Institutions (Regulation of Admissions and Prohibition of Capitation Fee) Act, 1983 (Act No. 5 of 1983) apart from imposing appropriate penalty under the APHERMC Act, 2019 and the APHERMC Rules, 2019 as amended subsequently from time to time;

- f. The institutions are cautioned to maintain proper accounts following lawful practices (Accrual/Mercantile basis of Accounting) including processing payments and receipts through Banks and follow the Regulations as well as guidelines of the Commission in submitting data for evaluation and regulation of fee proposals henceforth. In default their respective fee proposals are liable to be rejected under Regulation 5 (B) (viii) of APHERMC Regulations and such instances shall not be forwarded to the Government for fixation of fee.
- g. In case of any deviation from these directions, the Commission will initiate serious penal action as per the provisions of the Act and Rules made there under;
- h. Under Section 12(4) & (5) of A.P. Higher Education Regulatory and Monitoring Commission Act, 2019, the Commission has the power to review and determine the fee payable to the Higher Educational Institutions and review the fee determined, whether notified or not by the Government for any academic years/block periods; and
- i. The institutions are informed that the fixation of Fee structure by the Government will not by itself enable or permit the managements to run programmes, if the programmes are not recognized/permitted by the Government/ All India Council for Technical Education/UGC/NCTE and concerned University/ any other statutory Authority.
