ORDER:-

In the G.O. 3rd & 4th read above Government have notified the fee structure for M.B.A & M.C.A programmes offered by the private Un-aided Higher Educational Institutions in the State of A.P. for the block period 2023-26.

2. Whereas, the Member-Secretary, Andhra Pradesh Higher Education Regulatory and Monitoring Commission vide reference 5th to 16th read above, has proposed tentative fee / minimum fee for certain colleges/ new colleges/courses, mentioned in annexure (sl.no.1 to 23) for the block period 2023-26 and requested to notify the same. In view of urgency caused due to court cases and the then on going Pharmacy counselling, Government vide references 17th read above, have permitted the APSCHE to allow the above said colleges for counselling and notified the fee as recommended by the APHERMC for the block period 2023-26.

3. The Member-Secretary, Andhra Pradesh Higher Education Regulatory and Monitoring Commission in his letter 18th read above has stated, that the managements of some of the Colleges have failed to pay the processing fee within stipulated date/last date and some of the colleges did not upload the data online. Thus, the Commission has not recommended fee for these colleges. In the light of it, the managements of the following colleges have filed Writ Petitions and thereupon, the Hon'ble High Court of A.P., directed the Commission to fix the minimum fee tentatively and also directed the Higher Education Department of A.P., for listing the Petitioner Institutions and allotment of students/ admissions into pharmacy programmes for the present academic year 2023-24 in online admission process. It is further directed the colleges to furnish all the required data and on receipt of the same after due processing of the data, the Commission shall fix the correct/final fee at an early date for the block period 2023-26.

4. Whereas, as per the directions of the Hon'ble High Court, the Commission has issued notices to the above said colleges to attend the personal hearings held on 10.11.2023, 08.12.2023 for the scrutiny of the fee proposals. After scrutinizing the fee proposals submitted by the colleges, recommending the final fee structure to the colleges mentioned in Annexure (at Sl.No.24 to 27) for the block period 2023-26 and requested the Government to issue necessary orders, under Section 7 of Andhra Pradesh Educational Institutions (Regulation of Admissions and Prohibition of Capitation Fee) Act, 1983 (Act 5 of 1983) for the block period 2023-24 to 2025-26 .

5. After careful examination of the, Government have considered to fix the fee for M.B.A & M.C.A Programmes offered by the private un-aided Engineering Colleges, mentioned in Annexure to this order for the block period 2023-24 to 2025-26.

6. Accordingly, Government hereby issues the following Notification which shall be published in the Andhra Pradesh Extra-Ordinary Gazette:

NOTIFICATION

In exercise of the powers conferred under Rule 8 of the Andhra Pradesh Higher Education Regulatory and Monitoring Commission Rules, 2019 issued in G.O.Ms.No.49, Higher Education (UE) Department, dated: 11.10.2019 as amended subsequently from time to time, the Andhra Pradesh Higher Education Regulatory and Monitoring Commission recommended the fee structure for Private Un-Aided Professional Higher Education Institutions in the State of Andhra Pradesh offering M.B.A & M.C.A Programmes for the block period 2023-24 to 2025-26.

Further, in exercise of the powers conferred under Section 7 of Andhra Pradesh Educational Institutions (Regulation of Admissions and Prohibition of Capitation Fee) Act, 1983 (Act No.5 of 1983), Government hereby notify the Fee as mentioned in the Annexure appended to this Order for the block period 2023-24 to 2025-26, subject to following directions:

- a) The fee is an all-inclusive annual fee, including like tuition fee, affiliation fee, cost of identity card, medical fee, inter college/inter university sports, games & cultural meet fee, computer/internet fee, College magazine and student activities, student health care scheme, student welfare fund, study tour, alumni fund, sports and games fee, examination fee including stationery, maintenance and amenities fee, extracurricular activities fee, development fee, Recognition fee, Common Services fee and other recurring expenditure;
- b) The aforesaid fee determined for all the M.B.A., and M.C.A., Programmes for the colleges mentioned in Annexure (M.B.A. & M.C.A) does not include hostel, transport, mess charges, registration fee, admission fee and refundable deposits of library and laboratory fee.
- c) The same fee shall continue for the students admitted during the block period of 2023-24 to 2025-26 till they complete the programme.
- d) The institutions whose affiliations are not extended by the affiliating Universities for the academic year 2022-23 are not entitled to collect any fee;
- e) In case of a new college/course, the fee structure shall be the least of the fee regulated for the institutions in the same programme or course for the ensuing block period 2023 to 2026.
- f) The institution shall not charge either directly or indirectly any other amount over and above the fee fixed in the **Annexure (M.B.A. and M.C.A.)**. If any other amount is charged under any other head or guise i.e., donations, etc. the same would amount to charging of capitation fee and in that case the institution shall be liable to be prosecuted under Section 9 of Andhra Pradesh Educational Institutions (Regulation of Admissions and Prohibition of Capitation Fee) Act, 1983 (Act No. 5 of 1983) apart from imposing appropriate penalty under the APHERMC Act, 2019 and the APHERMC Rules, 2019 as amended subsequently from time to time;

- g) The institutions are cautioned to maintain proper accounts following lawful practices (Accrual/Mercantile basis of Accounting) including processing payments and receipts through Banks and follow the Regulations as well as guidelines of the Commission in submitting data for evaluation and regulation of fee proposals henceforth. In default their respective fee proposals are liable to be rejected under Regulation 5 (B) (viii) of APHERMC Regulations and such instances shall not be forwarded to the Government for fixation of fee.
- h) In case of any deviation from these directions, the Commission will initiate serious penal action as per the provisions of the Act and Rules made there under;
- i) Under Section 12 (4) & (5) of A.P. Higher Education Regulatory and Monitoring Commission Act, 2019, the Commission has the power to review and determine the fee payable to the Higher Educational Institutions and review the fee determined, whether notified or not by the Government for any academic years/block periods; and
- j) The institutions are informed that the fixation of Fee structure by the Government will not by itself enable or permit the managements to run programmes, if the programmes are not recognized/permited by the Government/All India Council for Technical Education/UGC/NCTE and concerned University/any other statutory Authority.
